### INFORMATION NOTE FOR RECRUITMENT PURPOSES

We hereby wish to inform you about the processing of your personal data by **BETFAIR ROMANIA DEVELOPMENT S.R.L.** and about the rights you have according to Regulation (EU) no. 679/2016 – General Data Protection Regulation (GDPR), of the Law implementing the GDPR provisions and the decisions issued by the National Supervisory Authority for the Protection of Personal Data (ANSPDCP) regarding the protection of personal data.

We process your personal data collected during the recruitment process strictly for the purpose of the efficient running of this process and in the event that we enter into an employee-employer contractual relationship.

**BETFAIR ROMANIA DEVELOPMENT S.R.L.** processes the personal data provided by you, with a view to your possible employment within our company, for the following purposes:

	<b>Candidate's professional history:</b> data on completed studies and data on previous employment history, professional skills, any other information that is required by law specifically for filling the available position.
	<b>Education:</b> copies of diplomas, transcripts, diploma supplement, student certificate, certificates, attestations, languages known, details of various courses taken.
	<b>Work permits:</b> work and/or residence permit in the European Union / European Economic Area (EEA) if applicable.

### What we do with them:

Your personal data are processed within the company BETFAIR ROMANIA DEVELOPMENT S.R.L. with headquarters in Bdv. 21 Decembrie 1989, no. 77, buildings A-F, et. 4, Municipality of Cluj-Napoca, District Cluj, Romania. The hosting and storage of your data takes place at our headquarters in secure cabinets, at Microsoft, a company that offers Office 365 solutions and that has hosting in Ireland, as well as at FlutterBe, DevSkiller and Beamery, companies that offer Human Resources and/or recruitment services and that have hosting in EU data centers. Employees of companies in the Flutter group can also access personal data from Office 365, DevSkiller, Beamery and FlutterBe.

If you participate in an interview at our headquarters, your personal data is shared with PP Protect, which acts as an authorized person for the operation of the CCTV cameras installed in the corridors of the BETFAIR ROMÂNIA DEVELOPMENT SRL headquarters.

At the same time, your personal data is also shared with companies within the Flutter group that act as associated operators for the reports necessary for recruitment and personnel management.

### How long do we keep your personal data?

The personal data collected for your possible employment within our company are kept for a period of 3 years, according to our internal data retention policies. Personal data captured by the CCTV system is kept for 30 days according to the institution's legitimate interest in protecting its assets and employees. After these terms have passed, your personal data will be anonymized or destroyed.

It is possible that, through the CV, you have voluntarily transferred to us, without us requesting through the job advertisement, a series of personal data such as hobbies, political affiliation, religious beliefs, family situation, etc. This data is not necessary for us in the recruitment process and accordingly, we will disregard it and will not use it for any evaluation, selection or any other purpose. At your request we can delete this data (CV or application form as the case may be) and you can resend us the necessary documents that do not contain the data as specified above.

If you have been selected to fill the available position and have accepted our employment offer, we have the legal obligation to retain your personal data collected as well as the documents submitted during the recruitment process for the creation of the employment file and the conclusion of the individual employment contract.

In the situation where you participated in at least one interview and were not selected for the available position, we will store your personal data for a period of 3 years from the end of the recruitment process, this being the limitation period for the right to notify a act of discrimination in the recruitment process in accordance with O.G. 137/2000 – on the prevention and sanctioning of all forms of discrimination.

### What are your rights?

If you have reason to believe that any personal data we hold about you is incorrect or incomplete, you have the right to request to see this information, have it rectified or have it deleted, request restriction of processing or object to processing, and you also have the right to portability of personal data.
